PRESIDENT'S MESSAGE

Dear LADS friends and colleagues,

Over the past two years I have experienced significant changes both personally and professionally. I think in life we all strive for stability and predictability, which creates a comfortable routine. It is inevitable that there will be experiences in our lives that divert us from our routine. One obvious example is the pandemic. We were all forced to close our offices, which placed stress on our practices as we continued to pay rent and ran payroll for our employees. Additionally, PPE was limited, patients were afraid of entering our offices and practicing dentistry was considered high-risk. As we struggled, we were waiting for answers to questions that could not be answered.

What amazes me is how resilient we can be and how innovative this country is. Leave the controversies aside - it is hard to lead when entering the unknown. But, if we are curious and willing to learn, this will result in positive outcomes. Three private companies developed vaccines within one year and the government released billions of dollars to aid small businesses like ours. Much of this money could be invested back into our practices for growth. Organizations such as the CDC, local health departments and state dental associations quickly developed protocols and toolkits to help us navigate through

this. None of this was perfect, but looking back I can't help but be impressed. During the shutdown (March - June 2020) I was homeschooling my five year-old daughter wondering how I would keep my practice going. Look where we are now!

Another important lesson that I have learned over the past two years is how to stay valuable. For example, many of my patients are busy professionals that work in Downtown Los Angeles. The pandemic seems to be permanently changing how people work. Many professionals are working only from home or commuting to the office a couple times per week. How can we become more valuable to our patients? This may require altering our practice time to accommodate patients' work

schedules, developing excellent recall and communication skills with our staff, sending gentle text reminders and incorporating Teledentistry. These are just a few basic adaptations that will help us thrive.

It has been an honor to serve as
President of the Los Angeles Dental
Society this year. I will continue to
volunteer my time though study clubs in
DTLA and through other committees as
needed. I sure wish I could have met
more of you over the past year, and I
know that this will happen as we plan our
social events and begin to open back up!

Continuing Education

"Saving Teeth Through Endodontic Therapy — What are the Outcomes and What is the Evidence?"

Tuesday, November 16, 2021 / Webinar 6:30 pm to 8:30 pm

The decision as to whether to incorporate an endodontically treated tooth in a periodontal/restorative treatment plan is often difficult. The availability of other successful treatment alternatives (dental implants) further complicates the issue. Yet, the retention of the natural dentition has many benefits for the patient. Endodontic success rates are high given new technologies and treatment modalities but is undeniably tied to restorative, periodontal, and other factors affecting the overall prognosis of the tooth. This lecture will focus on the evidence that endodontic therapy (initial therapy, retreatment, and surgical procedures) is still a viable and successful alternative in saving teeth which can be strategically used in restorative treatment plan. The prognosis for endodontically treated teeth will be considered.

Learning Objectives:

- 1. Learn the success rates of the various endodontic modalities.
- 2. Learn the application and viability of applying these modalities clinically.
- 3. Learn guidelines as to when and when not to rely on endodontically treated teeth based on their strategic value in the treatment plan and their prognosis.



Dr. Stefan Zweig, DDS, FACD, graduated from the University of California at Los Angeles in 1982 with a B.S. in Biochemistry. He received his dental degree from the University of Southern California School of Dentistry in 1986 and his Certificate in Endodontics from USC in 1992. Dr. Zweig maintained a faculty position at USC from 1992 until 1998 in the Department of Endodontics during which time he served as Associate Clinical Professor and the Assistant Director of Graduate Endodontics. Dr. Zweig is a Past President of the Southern California Academy of Endodontists and of the California Association of Endodontists. He has served on numerous AAE committees, and has been the Chairman of the Membership Services Committee, the Budget and Finance Committee, and the Special Committees to Form and Maintain the AAE Online Community (AAE Connection). He has served as a member of the

Board of Directors, the Treasurer, Secretary, and I Vice-President of the American Association of Endodontists, and currently as its President-Elect. Following a thirty-year career as a private endodontic practitioner, Dr. Zweig currently serves on the faculty of the Herman Ostrow School of Dentistry of USC as an Associate Professor of Clinical Dentistry in the Division of Endodontics and Orthodontics. He is a Fellow of the American College of Dentists.

It has already been more than a year when the COVID-19 pandemic changed our lives forever. In March 2020, dentists were forced to close their practices while quarantine was declared, seeing only emergencies as the hospitals in our country began to treat a surge of patients with COVID-19.

The pandemic affected dental education as well. At most dental schools, students stopped seeing patients in the clinic altogether and all in-person classes were continued on Zoom due to the "Safer at Home" mandate. At USC, the advanced specialty programs returned to clinic to see emergent patients before the dental students were able to return. The patients were required to take COVID tests and had to test negative for them to be seen in the USC clinic. Strict protocol was followed by faculty, residents, staff, and patients to prevent the spread of the virus.

Once the Los Angeles County lifted its restrictions, the dental students returned to clinic to see the predoctoral patients. On the second floor where the dental students saw their patients, the HEPA scrubbing filters could be seen at almost every other operatory. The number of patients seen

at a time was decreased to comply with the social distancing guidelines. The students and faculty were fitted with N95 masks and personal protective equipment (PPE). Friends and

acquaintances were almost unrecognizable with the layers and layers of PPE. The dental licensing exams such as WREBS were changed to typodont tests. The dental students

were transitioned to be tested on their clinical skills in scaling and root planing, restorations and root canal treatments on plastic teeth instead of live patients.

Due to the decrease in patient interaction time, there was a noticeable increase of dental students applying to residencies in order to strengthen their clinical skills. The interviews for the programs were conducted over Zoom and even the externships were also executed via Zoom, except for the prospective applicants who were already attending USC.

COVID changed how we approach dental education now and for the foreseeable future. Zoom lectures, meetings, and interviews as well as COVID and typodont testing are everpresent in our education. Although these are not a perfect replacement for live patient testing and in-person classes, I am grateful that these changes allow us to continue our work at the dental school.





Dr. Sonia Molina is a 27-year member and past president of LADS. She currently serves on the LADS Board of Directors as Chair of the Legislative Committee. In addition, in October of 2020, Governor Gavin Newson appointed Dr. Molina to the Dental Board of California. Dr. Molina will serve on the Dental Board until January 1, 2024.

Recently, we had the opportunity to ask Dr. Molina about her experiences and goals as both chair of the Legislative Committee and as a member of the California Dental Board. We are very proud of her as she gives her valuable time serving in these two positions. Dr. Molina, you are an inspiration to all LADS members!

Explorer: Let's start with your role as Chair of the Legislative Committee. What is your function in that position?

Dr. Molina: As liaison between CDA and our local component, my job is to stay informed about the different bills presented at the state level that would impact our profession.

Explorer: How often do you meet with various legislators? Perhaps you could name some of those you have met in the past.

Dr. Molina: We have a Legislative Day in the spring when our LADS members can talk to our state legislators about pressing issues affecting their practices. We have had breakfast meetings with City Councilmember Kevin De Leon (when he was in the State Senate), State Senator Ben Allen, County

Supervisor Holly Mitchell (also when she was in the State Senate), United States Senator Alex Padilla (when he was in the State Senate), to name a few.

Explorer: What have been some of the most crucial dental issues that you have addressed, either locally or as a Statewide concern?

Dr. Molina: Some of the most significant accomplishments of CDA this year have been securing \$230 million in our State Budget for new Medical Dental Program Benefits and fully funding the Office of Oral Health to support the State Dental Director.

Explorer: Are we at LADS "welcomed" as a "source" in the political arena? What is our reputation?

Dr. Molina: LADS is known for our diversity of our members as well as our inclusion. We are perceived as having always been on the cutting edge of the issues.

Explorer: How does your work affect or has already affected our membership?

Dr. Molina: One issue we fought for last year was stopping Delta Dental from reducing their fees.

Explorer: Do things in the legislative world move at a "snails "pace or fairly quickly?

Dr. Molina: The legislative calendar starts at the beginning of the year. The bills go through different committees in both the Assembly and the Senate during the year. In the Fall, the bills that made it out of all the committees are sent to the governor to sign into law or he vetoes them. When the bill is in a specific committee, we might contact our members so they can reach out to their elected officials to voice either their approval or opposition of the bill. So, during the year there are periods that things move very slow and then there are times we need to move very fast.

Explorer: Please tell us whom you have gotten to know? Representatives, local chairpersons, etc. It must be so gratifying when you can tell you are making a difference with changes and improvements.

Dr. Molina: Throughout the years I have gotten to know some of our elected officials, such as Senator Gill Cedillo (now Los Angeles City Council member), Senator Ben Allen, United States Senator Alex Padilla, State Senator Richard Polanco, State Assemblymember Wendy Carrillo.

Explorer: Now switching to your appointment to the Dental Board of California, what was your interest and experience with the Dental Board prior to being appointed a Board member?

Dr. Molina: I was appointed by Governor Davis to the COMDA (Commission on Dental Assistants) which was then part of the Dental Board of California. This position gave me a lot of experience on how the dental board meetings work and the function of the board.

Explorer: How did the appointment come about?

Dr. Molina: I was contacted by the governor's staff about my interest in serving my community and encouraged me to fill out an application.

Explorer: What are your responsibilities as a Board member?


Dr. Molina: The Dental Board regulates dentists and dental assistants to protect the public.

Explorer: What are your goals as a Board member for the rest of your term?

Dr. Molina: For the rest of my term, I would like to work on access to care. We are approaching a crisis when a lot of the dentists who are baby boomers will retire. There would be a shortage of dentists, especially in low-income communities.

Explorer: What would you like to tell LADS members about the Dental Board that they might not be aware of?

Dr. Molina: I would encourage our members to become familiar with the Dental Practice Act which is the body of laws in the California Business and Professional code that governs all dental professionals. ■

The Los Angeles Dental Society offers CPR courses that follow the American Heart Association's guidelines and satisfy the Basic Life Support requirements.

The Los Angeles Dental Society Radiation Safety Course is geared for entry level dental assistants or someone entering the dental field from another state. The course is designed for the student to take an online practical test, clinical lab hands-on instruction, and finally in-office supervision of patient x-rays. The course has been approved by the Dental Board of California.

During the clinical portion of the class, our instructor, Kristi Gallo, RDAEF2, will teach students how to take x-rays, input them and/or develop and mount them. Kristi started working in the dental field in 1994 as an RDA and has been teaching the Radiation Safety Class for LADS since 2018.

ELECTRONIC PRESCRIBING FOR CONTROLLED AND UNCONTROLLED SUBSTANCES BECOMES MANDATORY IN CALIFORNIA IN JANUARY 2022

QUICK SUMMARY:

PRESCRIBERS CAN CHOOSE TO PURCHASE A STANDALONE PRESCRIBING SOFTWARE OR A SOFTWARE APPLICATION ASSOCIATED WITH AN ELECTRONIC HEALTH RECORD. DENTISTS WILL WANT TO CONSIDER SEVERAL FACTORS BEFORE PURCHASING PRESCRIBING SOFTWARE, INCLUDING WHETHER THEY NEED TO USE THE SOFTWARE ON MOBILE PLATFORMS AND WHETHER THEY WANT ENHANCED SOFTWARE THAT PROVIDES ADDITIONAL FEATURES, SUCH AS THE ABILITY TO CHECK FOR DRUG INTERACTIONS OR A PATIENT'S DRUG ALLERGIES.

Beginning Jan. 1, 2022, dentists and other prescribers in California must issue electronic-data prescriptions for both controlled and noncontrolled substances with very few exceptions. Paper prescriptions will no longer be allowed by state law, as CDA previously reported.

All pharmacies across the state, too, must be capable of accepting those prescriptions and are required to immediately notify prescribers if the electronic transmission fails or is incomplete.

Assembly Bill 2789, which mandates the electronic prescribing, was signed into law in 2018, but CDA advocated for the three-year implementation window to give dentists time to obtain adequate e-prescribing systems and to train staff.

PURCHASING PRESCRIBING SOFTWARE

Electronic prescribing can especially reduce opportunities for diversion of controlled substances by eliminating the use of paper forms, which can be lost, stolen and used illegally. E-prescribing also can help provide timely patient care.

Prescribing software is available with or without the ability to electronically prescribe controlled substances. Software that can prescribe controlled substances costs more because of the additional regulatory compliance costs; the software must be certified that it complies with a 2010 DEA regulation that requires identity proofing of prescribers and two-factor authentication when signing prescriptions, for example.



Prescribers can choose to purchase a standalone prescribing software or a software application associated with an electronic health record. EHR-based applications allow for automation of patient demographic information and attachment of a prescription to the patient's treatment record. The applications can be added to Dentrix, Eaglesoft, OpenDental, Curve, Carestream or MacPractice. Providers can search for prescribing software applications on the Surescripts website.

MOBILITY. PRACTICE TYPE AND COST AFFECT SELECTION

Dentists will want to consider several other factors before purchasing prescribing software, including whether they need to use the software on Android, IOS or other mobile platforms and whether they want enhanced software that provides additional features, such as the ability to check for drug interactions or a patient's drug allergies.

The type of dental practice can affect software selection, as well. An associate who works at more than one practice may opt to purchase standalone prescribing software since it is not tied to a specific EHR, for example. And if a practice has multiple locations that use the same EHR, a separate user license for each location may be required.

EXCEPTIONS TO ELECTRONIC DATA PRESCRIBING

Prescribers can provide paper prescriptions directly to a patient only in situations that qualify as exceptions to the electronic

data prescribing mandate. Exceptions that may apply to prescribing dentists include:

The electronic data transmission prescription is not available due to a temporary technological or electronic failure of a computer system, application or device or a service interruption. If prescribing a controlled substance, the prescriber must document in the patient's record the reason for the failed electronic transmission.

- The prescriber is issuing a prescription for dispensing by a pharmacy located outside of California.
- The prescribing health care practitioner and the dispenser are the same entity.
- Prescribers can also call in prescriptions for noncontrolled substances in situations that qualify as exceptions under the state law, but only in emergency situations can prescribers call in prescriptions for schedule II drugs.

CDA reminds dentists registered with the U.S. Drug Enforcement Administration that the DEA is no longer sending renewal notices by mail as of June 2020. Registrants will instead receive renewal notifications by email.
