# Posterior Direct Restorations – Contacts, Complications, Sensitivity and Occlusion

# Oral Pathology - More than a Dental School Course

Tuesday, June 22, 2021/Webinar 6:30 to 8:30 pm

As we progressed through dental school all of us had to take several courses in oral pathology and most of us really did not care that much about it. It's hard, it made little sense to most of us, and it is one of those things that we have to do to get out of dental school. But oral pathology is real, albeit rare in our patients. This lecture will present an overview of the career of an oral maxillofacial surgeon and his exposure to and management of different pathologic lesions. While it is unlikely that most of you will be managing these patients, it is not impossible that you had or will have patients with lesions that we will discuss. Best of all there will be no final exam.

Educational objectives include:

- To review and describe a variety of pathologic lesions in adults and children.
- To identify epidemiologic characterizes of the lesions.
- To discuss treatment modalities for the lesions depending on their aggressiveness.



Alan L. Felsenfeld, MA, DDS, Professor Emeritus Oral and Maxillofacial Surgery, UCLA School of Dentistry, completed his dental education at the UCLA School of Dentistry and received his certificate in oral and maxillofacial surgery from Cook County Hospital in Chicago. He had a private practice in the East San Gabriel Valley for approximately 18 years prior to being invited to be full-time at the UCLA School of Dentistry. His focus while in full-time academics was in the training of residents to become oral and maxillofacial surgeons and treating complex patients referred to the medical center from the community.

Dr. Felsenfeld has a distinguished career in the political aspect of dentistry having served on the boards and president of many component, state, regional and

national levels in dentistry and oral and maxillofacial surgery. His career at the component level includes serving as the president of the San Gabriel Valley Dental Society. For the California Dental Association, he was on the Board of Trustees for 17 years including four as the editor of the CDA Journal and six as the Speaker of the House of Delegates. Presently he is a commissioner on the National Commission for the Recognition of Dental Specialties and Certifying Boards at the ADA and a member of the Dental Board of California. Dr. Felsenfeld has numerous publications and has given more than 150 presentations locally, nationally and internationally.

# DR. M. EBRAHIMI

Due to the pandemic this past year has been filled with uncertainty and many fears of the unknown. At the beginning, there were so many unanswered questions. Where did this virus originate from, how easily is it transferrable, what kind of personal protective equipment is most effective and many more. COVID-19 placed

everyone at some type of risk, especially those in the medical and dental community. Like most of my colleagues, a good percentage of our patients seek help while in some kind of dental pain. As an endodontist, I take pride in our profession, knowing that I can help individuals who may not have slept well the night before as a result of an inflamed pulp or an infection of odontogenic origin.

Death rates and infected individuals continued to increase in early March of 2020. Hospitals found themselves dealing with a huge influx of patients showing symptoms of this virus. I, among many other clinicians became scared to treat patients as I feared for



my life. Moreover, I feared the well being of my family, staff and patients. What if I am a carrier of this virus and somehow infect those around me? The stress and anxiety forced me to close my office by mid-March of 2020 following the CDC guidelines.

Endodontists go out of their way to help those in pain. We purposely leave small gaps in our daily schedule of patients just in case we need to accommodate those in pain. It could be an individual with a toothache or a referring dentist that needs to send a patient over for our services. We come into the office at odd hours for those that can no longer bare the agonizing pain they have been experiencing.

I have even placed my cell phone number on my website to allow potential patients or dentists to call or text me. For a good two-month period starting in mid-March, I had anxiety looking at my phone as it rang. I felt horrible when patients would call in pain. Sometimes, they were in such severe pain and felt so weak, that they could not talk over the phone. They would have a family member or a friend speak for

them. It was heartbreaking to hear myself telling them that I am not available to help.

As the weeks and months passed by, we learned more and more information about the nova coronavirus. Many endodontists, including myself, felt somewhat safe treating patients with the proper PPE. With the aid of the vaccines that are out and available to individuals, the number of deaths and infected people have drastically improved. I am hopeful that we will soon put this behind us and move forward.



The percentage of dentists who are women is growing, a trend that mirrors the makeup of dental schools and the general workforce.

"Dental school enrollment is now 50-50 gender split, so that is the main reason why we are seeing more dentists who are women in the workforce," said Marko Vujicic, Ph.D., chief economist and vice president of the American Dental Association Health Policy Institute. "The gender shift is not unique to dentistry at all. In fact, the majority of the U.S. labor force is now women."

Data from the Health Policy Institute show the percentage of dental school graduates who are women grew from 46% to 50.6% between 2009 and 2019 and the percentage of dentists in the workforce who are women grew from 24.1% to 34.5% between 2010 and 2020.

The workforce increase is expected to continue for several more years, based on the growth seen in female dental school graduates, according to HPI.

"We are going to see a steady increase in women in dentistry," Dr. Vujicic said. "HPI predicts the dentist workforce will reach gender parity by 2040."

The ADA is addressing the growing diversity of the dental workforce in several ways. The ADA Institute for Diversity in Leadership aims to enhance the leadership skills of dentists who belong to racial, ethnic or gender backgrounds that have been traditionally underrepresented in leadership roles. The ADA Accelerator Series also provides financial, leadership, self-care, and work and life tools to help dentists, particularly dentists who are women, move their careers forward.

At the local level, the Association partnered with Dallas County Dental Society and Procter & Gamble to launch a grassroots leadership program, Pathways to Community, that prepares and empowers female dentists to create their own communities and advance the success of women in dentistry.

"The future of the dental profession depends on how well and how fast we prepare dentists who are women for leadership roles to carry the ADA forward as women become the majority of the profession," ADA Executive Director Kathleen T. O'Loughlin, D.M.D., said. "The challenges are many — health equity, access to care, diversity within the profession to meet the needs of our communities, the cost of higher dental education and the social determinants of health that prevent our citizens from receiving the care they need and want. The speed of societal transformation is accelerating, and we are running out of time."

The ADA's 2020-2025 Diversity and Inclusion Plan, adopted in 2019, presents a framework for elevating the Association's diversity and inclusion efforts, as well as opportunities for measuring progress and results.

HPI data suggest the growing percentage of dentists who are women will have important implications for dental practice, Dr. Vujicic said.

"For example, the research shows that, all else equal, dentists who are women are less likely to own a practice, more likely to be in dental service organizations and more likely to treat Medicaid patients," he said. "They also earn less, even after adjusting for specialty and hours worked."

# NEW PROGRAM AIMS TO SUPPORT DENTISTS' MENTAL WELLNESS

# HOPE FOR THE DAY TO PROVIDE NEW MENTAL WELLBEING RESOURCES



The last year has been a challenging one for the dental profession. In addition to profound financial impacts, dentists reported the pandemic has impacted their mental and emotional health, according to a survey conducted by the New Dentist Committee.

In response to these findings, the ADA is developing new programs or enhancing current offerings to support the financial, physical and mental wellness of dentists and their teams. In particular, the ADA is focusing on developing new resources and tools aimed at reducing stigma, raising awareness and providing readily available materials to support mental health and wellness among members. These new programs and resources are made possible through a generous grant from Crest + Oral-B.

"This really hits home for so many new dentists. Having a community through organized dentistry to turn to means a great deal right now. Personally my mental health has been impacted by the pandemic, and I understand the need for dentists to have resources on mental health and know where they can go to get help." said Jarod Johnson, D.D.S., a member of the ADA New Dentist Committee, the group that spearheaded this effort. "We need to remember that our mental health is important to our overall health, especially as health care providers."

In July 2020, 311 new dentists responded to a survey from the New Dentist Committee to determine how they were impacted and rebounding from COVID-19. When asked to describe their current emotional state in one word, dentists said they were: worried, overwhelmed, stressed, anxious, concerned, hopeless and defeated. There were significantly fewer instances of positive feelings. In fact, 92% of respondents agreed that COVID-19 has challenged the mental health of dentists. These feelings echo national trends of elevated mental health conditions and increased suicide rates from heightened anxiety, isolation and many other stressors over the last year. Yet many dentists indicated they are not comfortable seeking out mental health resources for themselves or a staff member.

The ADA is seeking to change this.

Hope for the Day, a Chicago-based nonprofit focusing on mental health, has engaged the ADA in developing a series of mental health and mental wellness resources over the next six months. Hope for the Day aims to raise the visibility of information and resources in order to shatter the silence and dispel stigma surrounding mental health.

Hope for the Day was created in 2011 by Jonny Boucher, who decided it was time to take action and encourage others to seek help through educating individuals and allies after seeing too many of his friends die by suicide. The group has partnered with several organizations to specifically support military veterans, youth outreach and scientific research, among other efforts to reach target groups.

Proactive prevention is about creating an environment that doesn't wait for someone to reach a point of crisis to address their mental health. In doing proactive prevention, individuals step up to take action and facilitate the conversation on mental health in their spaces, and offer resources in hopes of avoiding ever reaching the crisis point.

Hope for the Day will draw from their experience in developing and disseminating physical and digital resources to more than 1 million people across the globe in 17 different languages to develop customized materials for the ADA and its members. Hope for the Day education programming is aimed at providing community members with the proper knowledge and tools on mental health care to help them achieve proactive prevention within their community. For the collaboration with the ADA, these materials are intended to support dentists as well as their dental teams.

Through their agreement with the ADA, Hope for the Day will produce a series of animated videos on how to recognize signs and start conversations with someone who may need mental health support.

Additional resources will include a webinar and a fact sheet for posting in dental offices. The group will also develop messages for the ADA to share across social media to elevate this issue and connect members with available resources.

The collaboration with Hope for the Day is first of two aimed at supporting dentists' mental health and wellness. The ADA is also engaging NAMI Chicago, an affiliate of the National Alliance on Mental Illness, to develop other complimentary resources. More details on both programs will be shared as resources become available.

# **COVID-19 IMPACT SURVEY**

THE IMPACT OF COVID-19 ON PRIVATE DENTAL PRACTICES IN LOS ANGELES COUNTY

#### **METHODS**

In November 2020, the LA County Oral Health Program asked the 5 dental societies in LA County to send their 5,548 members a link to an online survey regarding the impact of COVID-19 on office operations, services and their own wellbeing.

### **SURVEY RESPONDENTS**



- 469 full- or part-time clinical dentists completed the survey
- 82% were practice owners
- 79% were general dentists
- 61% had been in practice for 20 or more years

### TAKE AWAY MESSAGES

OFFICE OPERATIONS



Most dental offices in LA County (86%) were quick to respond to CDC's and CDA's recommendation to suspend elective care.



During the stay-at-home order (March 19-May19, 2020), the impact to dental personnel was extensive; most did not work (78%), and most were not paid (62%).

**DENTAL SERVICES** 



Dental offices resumed aerosol generating procedures (AGPs) once they had an adequate amount of PPE and infection control measures were in place.



By June 2020, most dental offices (75%) had resumed AGPs and by December 2020 almost all had resumed AGPs (90%).



Impact of COVID: Most dental offices (85%) reported that they are seeing fewer patients. New infection control precautions limit office capacity and many offices are short staffed.



Patient's fear of COVID is preventing them from seeking dental care.



Although some offices used teledentistry during the pandemic (32%), very few plan to continue using teledentistry after the pandemic (5%).

WELL BEING



The pandemic has tripled the number of dentists experiencing high levels of stress; 19% pre-pandemic vs. 58% currently. Many are experiencing problems with sleep and energy levels.



Dentists are most concerned about the cost of new infection control protocols combined with lower patient volume.




1-in-3 dentists feels somewhat or very uncomfortable treating patients during the pandemic.
